For admission under "Tuition Fee Waiver Scheme" for session 2010-11 in

Govt. Polytechnics/ Pvt. Un-aided Polytechnics in Himachal Pradesh

It is brought to the notice of general public that the "Tuition Fee Waiver Scheme" of AICTE is being introduced in all Govt. Polytechnics /Pvt. Un-aided Polytechnics (if ACITE approval obtained in case of Pvt. Polytechnics) in Himachal Pradesh for Physically Handicapped students, Women students and Economically Backward students in the ratio of 1:3:2 respectively for every 60 sanctioned intake in a branch/division of study having annual income less than 2.5 lac from all sources. Under this scheme, upto 10 percent seats of total sanctioned intake per course shall be available for these admissions. In case of non-availability of candidate in a specific category mentioned above, the benefit will be given to the candidate of other categories according to merit of PAT. The seat once allotted will not be changed after 2nd round of this counseling under any circumstances.

All Bonafide / Domicile Himachali candidates belonging to above categories, whose annual income is less than 2.50 Lac from all sources (attach income certificate with application form) and have qualified the Polytechnic Admission Test (PAT) –2010, shall be eligible for admission under this scheme. The admission under this scheme shall be on the merit of marks obtained in PAT –2010 conducted by the H.P. Takniki Shiksha Board, Dharamshala. Other rules and conditions as per Prospectus for Admission to Polytechnics in H.P. for session 2010 shall remain the same. The desirous candidates shall have to apply on the application form given below to the **Principal, Govt. Polytechnic, Sundernagar** on or before 07 June 2010 alongwith photo copies of relevant certificates. The schedule of counseling for Tuition Fee Waiver Scheme only is as under :-

1st Round of Counseling - 08 June 2010 at 10-00 AM - Upto 200 marks in PAT
09 June 2010 at 10-00 AM – Upto Pass marks in PAT

2nd Round of Counseling - 04 Aug 2010 at 10-00 AM for vacant seats (if any).
